FUTURE TOPICS

- 1. Intersection between what the City is going to do to its infrastructure to mitigate sea level rise and how this ties into individual property owners.
 - a. Discussion held by J. Koslowe regarding interest in reporting from City staff on projects about sea level rise and how to facilitate private property issues for property owners and so Commission can devise policy to direct staff, as needed. Timelines of projects. C. McCord requests city staff to talk about emergent challenges and how staff is addressing. Ex/ harmonization agreements Indian Creek project (Kevin Pulido to present)
 - b. Discussion of how rainwater from private property is taken into consideration when designing the new stormwater system. Property by property harmonization plan to account for this (C. Ortega).
- 2. Undergrounding of electric infrastructure by FPL Staff presentation requested (David Martinez or Joe Gomez)
 - a. J. Koslowe requests staff to research new undergrounding program and to explain to Committee so they can advise Commission if action is recommended. Stated that Coral Gables is doing this. There is a new statewide program. G. Treuer discussed potential for overlap in undergrounding electric with ongoing infrastructure projects.
- 3. Resilience Projects and how they may affect the ability of a building to acquire flood insurance
 - a. R. Starkman asks for clarification on implications of projects and flood insurance eligibility from appropriate staff. A. Knowles explained that road elevation does not create basements per FEMA definition. The issue that made the news in Sunset Harbour was clarified by the insurance company and the city did not create a basement condition. A forensic engineering inspection/ report was done to clarify that the building is not a basement, road elevation is not a consideration in flood insurance.
