COMMITTEE BUSINESS

Quorum Update

Amy shares update regarding quorum requirements for 2024. In-person attendance is required to count towards quorum; virtual attendees can attend but will not be able to vote. Environment & Sustainability Department conference room is suggested as possible meeting place for next year.
